This correspondence announces the vacancies and other information regarding our annual election. The role of an ILAPPS Board member is very important. It requires volunteer services and sincere dedication. Please take a minute to read the text below as you look towards the upcoming event, April 21-22, 2017.

All Illinois process servers have benefitted from the work ILAPPS has done on behalf of our Members in Good Standing. But only a very small percentage of all process servers in Illinois have supported this organization.

Over the past 3 years the association has managed to function with a budget no greater than \$13,000. In the future this will not be enough to sustain the organization.

Funding sources consist of membership dues, conference registrations, ad book advertisements, sponsorships & vendors. Funds are used for basic office expenditures that provide services like Constant Contact or www.ilapps.com; cover pay for the Executive Director; and the annual conference.

In the past 3 years the Board has accounted for 90% of the sponsorships for ILAPPS. Moreover, educators and special guests speakers have also volunteered their time in civil service for the ILAPPS mission. There is no question that without them ILAPPS would no longer exist.

ILAPPS encourages you to urge fellow professionals to join us so that efforts to secure everything that governs the service of process.

Policy and Procedure

- To be placed on the ballot for the election to be held on April 22, 2017 for the following officer positions: President; Vice President; Treasurer; Secretary:
 1. You must be an ILAPPS Member in Good Standing for at least two consecutive years.
 2. *You *must* submit a letter of nomination within 30 days prior to the election. You must submit letter of nomination no later than March 25, 2017.
 3. You must be present during the membership meeting for the election on April 22, 2017.

- To be placed on the ballot for the election to be held on April 22, 2017 for the following director positions: Northern; Central; Southern; At-Large:
 1. You must be an ILAPPS Member in Good Standing for at least two consecutive years.
 2. *You *may* submit a letter of nomination within 30 days prior to the election. Please submit letter of nomination no later than March 25, 2017.
 3. Prior to the election, you may announce by plurality at the beginning of the membership meeting, that you wish to be considered for a director position.
 4. You must be present during the member meeting for the election on April 22, 2017.

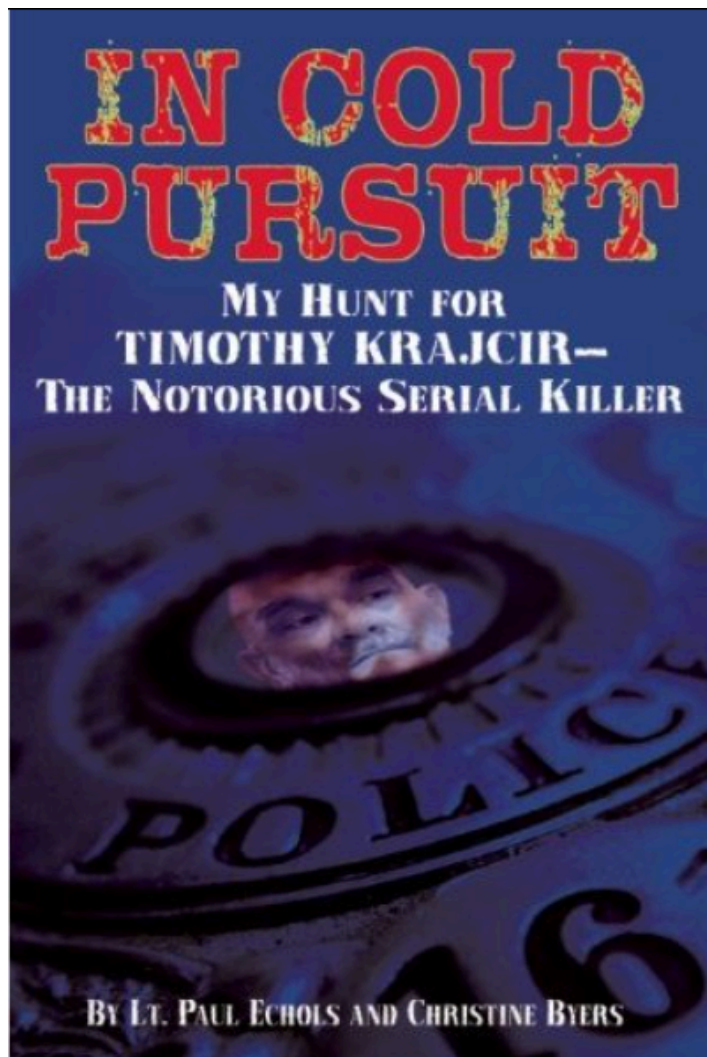
